

## The Postal Museum Images Terms and Conditions of use

- 1. 'The Postal Museum' means The Postal Museum, Phoenix Place, WC1X 0DA
- 2. 'Client' means the client named overleaf
- 3. 'Images' means any photograph, transparency, electronic image or any other item which may be offered for the purpose of reproduction
- 4. 'Reproduction' means any form of publication or copying of the whole or part of any picture by any means
- 5. Images may not be stored by the client beyond the agreed period and should be deleted or destroyed after use
- 6. No property or copyright of any images will pass to the Client through the grant of reproduction rights
- 7. The Postal Museum reserves the right to refuse any reproduction request at its discretion

## Where granted, reproduction rights are:

- 8. Non-exclusive
- 9. Strictly limited to the terms, use, period of time and territory specified in the Licensing Permission Form
- 10. Not be assigned or sub-licenced to any third party
- 11. Permitted by The Postal Museum only when permission is specifically stated and if applicable a fee for the reproduction has been agreed, an invoice issued and the total amount paid in full by the Client
- 12. Images shall not be manipulated, altered or have any part deleted without the prior written consent of The Postal Museum
- 13. It is the Client who must satisfy themselves that all necessary rights, model releases or consents which may be required for reproduction, are obtained and that the use of any image is not obscene, libellous or unlawful. The Postal Museum gives no warranty or undertaking that any such rights, releases or consent are or will be obtained whether in relation to the use of names, people, trade marks, registered copyright designs or works of art depicted in any picture. In the event that the picture is used or reproduced by or with the authority of the Client, the Client shall indemnify The Postal Museum against any loss, damaged proceedings or costs where such rights, releases or consent have not been obtained
- 14. The Client must accompany any reproduction of a picture with the appropriate credit line as advised by The Postal Museum. In the event of reproduction without the appropriate credit line, the Client will be liable to pay an additional 50% of the original licence fee
- 15. One complimentary copy of any publication, broadcast or electronic reproduction containing any reproductions of The Postal Museum pictures is to be supplied to The Postal Museum within one month of creation

- 16. Whilst The Postal Museum has taken reasonable care to identify, caption and orientate the images, it does not accept any liability for loss or damage incurred by the Client or third party caused by any errors connected therewith
- 17. The Client warrants that the text of the publication is their own and The Postal Museum does not accept any liability for the accuracy or content of the text
- 18. Payment terms are 30 days from the date of invoice
- 19. The Client agrees to indemnify in respect of any claims, damages, loss or costs arising from the reproduction of an image or the subject of an image in a defamatory or misrepresentative manner or in any way that contravenes the Copyright, Designs and Patents Act 1988
- 20. This agreement is subject and construed according to English law and the parties agree to accept the exclusive jurisdiction of the Courts of England
